Senior Privileges Revoked *Off-Campus Privileges Suspended due to Extensive Consumption of Alcohol During Day-time Party*

The administration has officially ended senior off-campus privileges as a result of a recent party held during school hours on Bar Beach Road. The estimated 150 students at the party were consuming large quantities of alcohol, and as a result of a recent School Board decision stemming from a previous Bogart Avenue party, the right of upper-classmen to leave school grounds was revoked.

According to Assistant Principal Alphonse Campbell, "The students were warned. If they're not going to be able to handle the responsibility of going off-campus, then it would be inappropriate for us to let the practice continue." According to Mr. Campbell, the privileges are to be revoked as of Monday, April 6. Any student caught off-campus after that period will be suspended. Principal Sid Barish stated, "The revocation is absolute. Students were asked to refrain from alcohol parties during school." When asked how this action will affect off-campus privileges in the future, Dr. Barish responded, "There's nothing to make me think that next year's seniors will be any better. It's just too bad that seniors will have to remain on campus forever."

The party took place on Friday, March 27. Students gathered in and around the house, and appeared to consume massive volumes of alcoholic beverages. Although one student professed that the "kegs were full of root beer," the

administration felt differently. The party began at 8:30 a.m. that morning and lasted until the administration arrived at 11:45 a.m. The administration learned of the party through an inside source, an unidentified narcotics agent, or "narc," who is presently enrolled at Schreiber. Upon learning of the party, the administration responded by immediately rushing to the student's house and removing the keg. Minutes after the keg was taken, students voluntarily dispersed.

Sixty-five students received two days of after-school detention as a result of the party. Although the administration was unable to confirm any of the students' attendance at the party, one administra-

tion arrived at the house; since it appeared that the student was completely unaware of any of the day's events and did not condone the party, he only received three days of detention.

The administration exercised its right to remove senior off-campus privileges following a brief meeting on Friday afternoon. Administrators then held a closed-door "star chamber," where the selected students received their punishments.

In order to enforce the new regulation, the administration has hired two more security guards. These truant police will patrol the usual student hang-outs: G & J's, Carnel's, and B.K. In addition, the administration is negotiating a contract whereby the Port Washington Police will be on the lookout for high-school age students all around town. One officer remarked, "What you're looking at is your basic teen curfew—during the school days." According to Dr. Barish, a padlock will be placed on the Monfort parking lot after 8:30 a.m. "This should keep students from trying to flee the town," he

schedule, much like that at Weber Junior High. Students will be required to take

seven classes and will have one lunch period and a designated study time, during which they will be required to sign in and remain seated.

In a Schrieber Times survey, 97.3 percent of Schrieber students stated that they were against the proposed changes. One student who voted in favor of the changes exclaimed, "Hey I'm graduating anyway." 74 percent of the students surveyed supported the changes. One parent remarked, "Students these days, they're just too irresponsible. They don't deserve to have these privileges. In my day, on weekends we stayed inside and listened to the radio. There was no beer; we drank milk and ate cookies, and if we were lucky we saw a show at the cinema. We were bored and we were tired, but we liked it!" Another parent commented, "I can't believe the students drink alcohol. I have no idea where they could have picked up such evil habits! It must be in that rock 'n' roll music." One Schrieber teacher, who asked not to be identified, stated, "It's all been downhill since they shot JFK."

Battle of the Bands is Suspended

Barish Slams Schreiber Tradition over Slam Dancing

The Schreiber Administration announced on Monday, March 30 that the Battle of the Bands event would be indefinitely suspended as a result of the disruptions at this year's Battle. Principal Sid Barish cited several incidents of "moshing" and student fighting as the rationale for the suspension.

Dr. Barish explained the suspension of the Battle, saying, "The Battle this year was just too dangerous. We cannot have students throwing themselves into each other at a school event. They can dance like that at home, or at least when we aren't looking. Show some class."

As a result of the moshing, three students were injured and two spent the night in the hospital. The third student, whose name was withheld by the administration, checked into a drug rehabilitation center at the night's conclusion.

Furthermore, the administration authorized a committee of teachers, parents, and students to examine violence at the Battle. The fifteen-person committee plans to conduct surveys on a state and local level and will examine other relevant studies from other schools. "You'd be surprised by how much information there is around," commented Dr. Barish. The committee plans to meet bimonthly and anticipates a resolution as early as 1995.

"Until then," stated Dr. Barish. "We're not going to be able to have a battle."

The Student Government did not appear to be concerned about the news. Co-advisor Amy Prochaska stated, "The Battle of the Bands is only one G.O. event. I'm sure many new programs will rise up to take its place."

The G.O. has already envisioned a new event to replace the Battle. President senior Tim Browne stated, "Schreiber

students need an outlet for their musical talent. In place of the Battle, we plan to hold a musical Polka Fest. Students will be able to demonstrate their talents playing popular polka pieces on the accordion, the glockenspiel, and the English Horn. I'm sure that all the students will really stack up behind it, and besides, I'm graduating."

Dr. Barish expressed that while he is not against Battles in the future, the trends in music has really degenerated, which may have led to the disruptions. He stated, "Metallica, Faster Pussycat, Gun's 'N Roses? That's not real music. What ever happened to Anthrax, Megadeth, and Suicidal Tendencies? It's this fake metal that's been causing the moshing; these kids are slam-dancing out of a suppressed boredom. If we got a little more speed metal and a little less of this 95.5 pop junk, then maybe we'd really have an event!"

The reactions of the band members to the news differed. Autumn Pool Tribe vocalist Greg Kirmser was furious. He stated, "God darn! It's not fair. But, hey, I expected it. After all, it's all politics anyway." However, Breadhammer vocalist Jason Wright responded, "Yeah ... Polka Fest. I'm in." And Suckafish drummer Peter Fishman added, "The Polka Fest is all about rock 'n' roll, and so is Suckafish." While Desolation Angels vocalist James Berroya was in favor of the Polka Fest, he had some reservations: "Chances are that we'll get disqualified from this as well. Those polka dancers can get downright vicious."

Another senior added, "The Battle this year was OK, but I was a little disappointed with the lack of parties following the event. Maybe next year's polka will be different."

The administration's statement also

cited several minor reasons for the suspension of the Battle: "We believe that the guidelines for the Battle are discriminatory. Students with more musical talent are clearly given preference in performing than students with less. We would like that in the future all prize money be awarded on an equal basis, regardless of the bands' individual per-

formances."

Student Government Treasurer senior Peter Han stated that suggestions for future Battles include a steel cage to surround each Band and steel chains for the audience. "If this is what it takes, there will be real heavy metal at Schreiber." He added, "And besides, I'm graduating."

Students Sick of Being S.A.F.E.


